

This Ministry has been implementing the scheme of National Scholarships Scheme for Higher Education to encourage meritorious ST students to pursue courses at Graduate and Post Graduate level courses in premier institutes identified by the Ministry in professional fields such as Management, Medicine/Science Engineering and Technology, Humanities, Law and Social Science etc. Prior to 2021-22, a total of 1000 students were selected for scholarship under the scheme. With effect from 2021-22, all ST students with annual family income not exceeding Rs. 6 lakhs are eligible for scholarship
